2. Points Recognized in the Certification

The following points were recognized upon receiving certification.

[Konoha Mall Hashimoto]

- (1) Excellent initiatives on energy conservation and resource saving through the adoption of rainwater, solar panels, water-saving toilet systems for all toilets and LED lighting in common areas.
- (2) Measures against heat island effect are also taken with the greening of the Garden Court and exterior walls, in addition participation in community clean-up activities once a month.

[Higashi Hie Business Center II]

- (1) In addition to adoption of low-e pair glass and LED lighting in common and exclusive areas, the property has taken excellent initiatives in energy saving and resource saving, such as through the installation of a water-saving toilet system and in the use of rainwater.
- (2) The property offers comfortable office environments that can accommodate flexible partitioning with ceiling height, floor loading, grid ceiling and so on.

3. Outline of DBJ Green Building Certification Program

The DBJ Green Building Certification Program was launched by the Development Bank of Japan Inc. ("DBJ") in April 2011 for the purpose of supporting properties which give proper care to the environment and society (Green Building).
