**Notification of Stock Repurchase and Cancellation of Treasury Stock**  
**(Stock Repurchase in accordance with the paragraph 2 of Article 165 of**  
**the Companies Act of Japan and cancellation of a part of treasury stock in accordance with the**  
**Article 178 of the Act)**

At the meeting of the Board of Directors held on October 30, 2019, Mitsui & Co., Ltd. (“Mitsui”, Head Office: Tokyo, President & CEO: Tatsuo Yasunaga) resolved to repurchase its stock in accordance with Article 156 of the Companies Act of Japan, as applied pursuant to paragraph 3 of Article 165 of the Companies Act of Japan and to cancel a part of its treasury stock in accordance with Article 178 of the said Act. Details of the repurchase and cancellation are as follows:

1. Purpose of stock repurchase and cancellation of treasury stock:

To enhance shareholder return and to improve capital efficiency.

2. Details of repurchase:

- (1) Class of share: Common stock of Mitsui
- (2) Total number of shares of common stock to be repurchased: Up to 30,000,000 shares  
(1.7% of the total number of shares of common stock outstanding excluding treasury stock)
- (3) Total amount: Up to 50,000,000,000 yen
- (4) Period: From October 31, 2019 to March 24, 2020
- (5) Repurchase method: Auction market on Tokyo Stock Exchange

3. Details of cancellation:

- (1) Class of share: Common stock of Mitsui
- (2) Total number of shares of treasury stock to be cancelled:  
All of the shares of common stock to be repurchased pursuant to 2 above  
(Up to 1.7% of the total number of shares outstanding)
- (3) Scheduled date of cancellation: April 20, 2020
